The functions of the State Planning Board are as follows:

- (1) To provide overall guidance in the formulation and implementation of Five Year Plans and Annual Plans;
- (2) To suggest policies for optimum utilization of natural and human resources.
- (3) To advise on evolving appropriate policies and programmes towards reduction of regional imbalances in the State.

- (4) To suggest measures to improve the investment climate in the State economy in tune with the Economic Reforms at the Centre.
- (5) To advise on investment levels required under Plan and resource mobilization for the same.
- (6) To suggest appropriate strategies and priorities in the State Plan within the frame-work of the National Plan.
- (7) To review the implementation of plan programmes/ projects and to recommend suitable measures for effective implementation.
- (8) To recommend measures to improve decentralized planning and implementation particularly at district and taluk levels and to integrate these plans with State sector plan.
- (9) To make recommendations on matters which may be referred to it by the Government from time to time.

Sanction is accorded to the payment of

- (1) TA to the non-official members of the Board as per List under Annexure (A) to WSR; and
- (2) DA and Sitting Fee in lieu of DA wherever applicable at Rs.300/- per day for attending the meetings of the Board.

The expenditure on this account shall be debitted to the head "3451-Secretariat Economic Services - 00 - 101 - Planning Commission - Planning Board - 4 - 00".
