**PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA**

Sub: - Posting of Shri Krishnamurthy Maiya, ISS (Indian Statistical Service –1986) Ministry of Programme Implementation, GOI presently working as Director, NSSO (FOD), E&F Wing, Kendriya Sadan, Bangalore, as Research Consultant to State Planning Board.

Preamble: -

Deputy Chairman, State Planning Board, had proposed Hon'ble Chief Minister and Chairman of State Planning Board to accept the willingness of Shri Krishnamurthy Maiya to work on deputation as Research Consultant to State Planning Board on his own pay and scale with the existing terms and conditions of deputation, who is working in Government of India, as Director (Region), NSSO (FOD), E&F Wing, Kendriya Sadan, Bangalore.

In the letter read at (2) above, request was made to Government of India, to spare the services of Shri Krishnamurthy Maiya (ISS-1986), on deputation to Karnataka State Planning Board on his own pay and scale with usual terms and conditions.

In Office Memorandum referred at (3) above, approval is conveyed for posting of Shri Krishnamurthy Maiya, Director, NSSO, with Government of Karnataka on deputation basis as Research Consultant to State Planning Board on the existing terms and conditions.

**Government Order No. PD 32 SPB 2009**  
**Bangalore, Dated 25<sup>th</sup> February 2010**

Sanction is accorded for the deputation of Shri Krishnamurthy Maiya, (ISS-1986), Director, NSSO, (FOD), E&F Wing, Kendriya Sadan, Bangalore, as Research Consultant to State Planning Board for a period of one year from date of reporting on the existing terms and conditions.

**The terms and conditions of deputation are as follows**

1. The deputation of Mr. Krishnamurthy Maiya will commence on the date on which he assumes the charge of the post in the State Planning Board.
2. During the period of deputation, Mr. Krishnamurthy Maiya shall receive salary and other emoluments as per his own pay and scale applicable to the post he holds in his parent department from the State Planning Board.
3. The payment of DA/HRA/CCA shall be provided under the Central Government Rules.
4. Mr. Krishnamurthy Maiya will be entitled to T.A, D.A. and joining time on reversion to the parent department under the rules of the State Government.
5. During the period of deputation he will continue to be governed by the leave and pension rules of the Central Government.
6. During the period of deputation, he shall continue to subscribe to the Central Government Employees Group Insurance scheme and the borrowing Government shall credit recovery effected to the relevant head.
7. During the period of deputation he shall continue to subscribe to the Provident Fund of his Parent Department to which he may be subscribing where he is placed on deputation in accordance with the rules of such fund.
8. The Officer shall be entitled to the Medical facility as per the Karnataka Government Servant (Medical Attendance) Rules, 1963.
9. The Officer shall be entitled for both LTC/HTC during period of service in the Planning Board on deputation as per Central Government Rules.
10. For journeys undertaken after joining on deputation he shall be entitled to receive TA and DA as per the State rules under borrowing Government.

This order issues as per the delegation of powers vested with the Member Secretary, State Planning Board vide Govt. Order No. PD 113 SPM 1996 dated 17<sup>th</sup> May 1997.
